## WPCSNZ REGISTRATION INFORMATION as at April 2024

## The breeding year is from 1<sup>st</sup> of August to the 31<sup>st</sup> of July.

Once registered with the Welsh Pony & Cob Society of New Zealand (Inc.) the pony or cob will be designated a registration number unique to that pony. This records all of the details associated with that pony such as breeding, colour, brands and breeder

## APPLICATIONS WILL NOT BE ACCEPTED UNLESS ACCOMPANIED BY

- Stallion Service Certificate (White page) may be scanned and emailed
- Registration Application Form
- Photographs showing head & both sides (including hooves)
- Correct Registration Fee

A Stallion Service Certificate (SSC) signed by the stallion owner is required if the Sire is Registered Welsh and to be included with the registration form. \*See reciprocal registration information below regarding registration of animals which are already registered with other societies.

Photos can be emailed. Please ensure that you provide clear full body photos from the near and the off side, and of the pony's face.

All paperwork for any Welsh Registrations must be received by the Secretary by the 31<sup>st</sup> of July of that breeding season.

After this date a late fee and or DNA Parent Verification shall apply,

**Late Fee**: After 31 July of season of foaling - \$50 for up to 1 year thereafter. After this period they are **Late Registrations** – whereby DNA Parent Verification of foal is required.

The required 12.5% Welsh blood can be accumulated from a combination of the sire or dam's proven registered Welsh blood.

## \*RECIPROCAL REGISTRATION – For Partbreds only

A pony that has at least the minimum 12.5 % Welsh blood and is not able to be registered by DNA parent Verification but is registered with another society such as the PBSNZ and NZRPS is eligible for reciprocal registration. Some other registrations such as German Riding Ponies may be eligible subject to pedigree verification of registered Welsh blood percentages.

Ponies must have been registered by other Societies before the 31 July of their Foaling Year. If the owner is the breeder of the animal a Partbred Welsh Registration Form is required and a reciprocal registration form cannot be used.

If the pony can be registered by (Welsh) DNA Parent Verification then a reciprocal registration form cannot be used.

**RECIPROCAL REGISTRATION FEES** - The Fee for Partbred Reciprocal registrations (excluding Stallions) is \$100 per animal

Reciprocal Registration of a Stallion must follow all Partbred Stallion Regulations. (DNA Parent Verification) and the Colt to Stallion current Registration Fees.
